जहां तक, परमाणु ऊर्जा विभाग के विकिरण एवं आइसोटोप प्रौद्योगिकी बोर्ड (विआप्रौबो) का संबंध है, क्रम संख्या 6 और 7 का उत्तर निम्नानुसार है/ As far as the Board of Radiation and Isotope Technology (BRIT), Department of Atomic Energy is concerned, reply to the queries at serial number 6 and 7 is as follows:-

1.	6- Article 34 of the RPwd Act 2016 which has been defined in the format by identifying locomotor disability under Category-C and several Ministries / Departments of the Government of India (Group A) have identified the post by adopting them as it is (Kindly take note of point 1 and 2 above) and the above mentioned order of the Hon'ble Court has been complied with. But on the contrary by several other Ministries/Departments of the Government of India (Group B kindly take note of point 3) in a discriminatory manner by ignoring and tampering with the provisions/guidelines made in the Act (Kindly note section 20 discrimination of the Act) The posts have been identified by subdividing the locomotor disability on gender basis (OL BL BLA OLA OA ETC), thereby depriving a large section of LDs from employment opportunities including locomotor both leg affected. Kindly inform that the Ministries/Departments (Group A) mentioned in the above point 1, 2 (who have identified the post by adopting Section 34 of the RPWD Act as it is) OR Point 3 by which of the Ministers/Departments (Group B) (whose posts have been identified discriminatory on the basis of gender) of the Hon'ble Supreme Court order of Section 33(ii) and 34 of the RPWD Act, 2016 duly complied with.	Based on the nature of job and area of work, PWD candidates are considered for Scientific and Technical posts. Administrative and Auxilliary category posts are open to PWD candidates also.
2.	7. The above mentioned decision given by the Hon. Supreme Court with reference to Shri Anuj Goyal's (PIL) public interest litigation has been complied with by the Ministries/Departments under Group A under the RPWD Act 2016. Or by Ministries/Departments falling under Group B, kindly inform the RTI application by referring to the above points.	Question is not clear
