#### INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING

### PART-A: GUIDELINES FOR E-TENDERING :-

#### **Instructions for Online Bid Submission**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

#### 1. REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.

- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

#### 2. SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e- mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### 3. PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/ JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or 'Other Important

Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.

#### 4. SUBMISSION OF BIDS

- 1) Bids shall be submitted online only at CPPP website : <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>
- 2) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 3) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 4) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.
- 5) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 6) The agency shall download the pre bid clarification if any for the work and upload the same (scanned copy) duly signed and sealed. The revised documents (if any) shall be uploaded in e tender portal.
- 7) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the SKY BLUE coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 8) Tenderers are advised to upload their documents well in advance, to avoid last minutes

- rush on the server or complications in uploading. BRIT, in any case, shall not be held responsible for any type of difficulties during uploading the documents including server and technical problems whatsoever.
- 9) Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 10) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 11) Submission of the tender documents after the due date and time (including extended period) shall not be permitted.
- 12) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 13) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 14) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 15) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.
- 16) Intending Bidders are advised to visit this website regularly till closing date of submission to keep themselves updated as any change/ modification in the tender will be intimated through this website only by corrigendum / addendum/ amendment.

#### **5. ASSISTANCE TO BIDDERS**

- 1) Any queries relating to the tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.

## PART-C: REQUIREMENTS AND ELIGIBILTY CRITERIA

- 1 INITIAL CRITERIA FOR ELIGIBILITY FOR PRE-QUALIFICATION:
  - The applicant who fulfils the following criteria shall be considered for participation. **Joint Ventures and Consortium etc. shall not be accepted.**
  - **Proof of registration** with Government / Semi Government organizations like CPWD, MES, BSNL, Railways, State PWDs etc. in appropriate class OR having experience in execution of similar nature of works.
- 1.1 Proof of registration with Government / Semi Government organizations like CPWD, MES, BSNL, Railways, State PWDs etc. in appropriate class or having experience in execution of similar nature of works.
- 1.2 The applicant should have satisfactorily completed the works as mentioned below during the last seven years ending previous day of last date of submission of tenders.

**Completed three similar works** each costing not less than ₹ 54.49 lakh

#### **Completed one similar work costing not less than ₹ 108.99 lakh.**

#### **Important Notes:**

- a) Similar work shall mean: "Any Electrification works for Indoor/
  Outdoor applications"
- b) Cost of work shall mean gross value of the completed work including the cost of materials supplied by the Client, but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer/Project Manager or equivalent.
- c) The value of executed works shall be brought to the current costing level by enhancing the actual value of work at a simple rate of 7% per annum; calculated from the date of completion to the last date of submission of tender.
- **d)** If the eligible similar works are not carried out in Central Government/ State Government/ Public Sector Undertaking of Central or State Governments/ Central Autonomous bodies, then TDS certificate along with similar works completion Certificates.
- 1.3 The applicant should have had average annual financial turn over (gross) of ₹ 137 lakh during the immediate last 3 consecutive financial year ending 31st March, 2024. This should be duly audited by a Chartered Accountant. Year in which no turnover is shown would also be considered for working out the average.
- 1.4 The applicant should not have incurred any loss in more than two years during the last five consecutive immediate financial years ending 31st March, 2024 duly certified by the licensed charted Accountant.
- 1.5 The applicant should have Latest solvency of ₹ 54.49 lakh from any scheduled bank not earlier than one year from the date of Tender Opening.
- 1.6 The bidding capacity of the contractor should be equal to or more than the cost of the work. The bidding capacity shall be worked out by the following formula:

Bidding Capacity =  $A \times N \times 2 - B$ 

Where,

A= Maximum turn over in construction works executed in any one year during the last five years taking into account the completed as well as works in progress. The value of executed works shall be brought—to current costing level by enhancing the actual value of works at a simple rate of 7% per annum.

N= Number of years prescribed for completion of work.

B = Value of existing commitments and ongoing works to be completed

during the period of completion of work for which tender has been invited.

- 1.7 List of works in hand & List of similar works carried out by them for last 7 years indicating (i) Agency for whom executed, (ii) Value of work, (iii) Completion time as stipulated and actual, or present position of the work.
- 1.8 **List of construction plant, machinery**, equipment's, accessories & infrastructure facilities possessed by the agency to complete the work in time.

The applicant should have sufficient number of Technical and Administrative employee for the proper execution of the contract. The applicant should submit list of well qualified and experienced Engineers and Supervisors stating clearly how those would be deployed for execution of works.

#### 1.11 UNDERTAKING as under:

I / We, hereby tender for the execution of the work for the President of India within the time specified in Schedule "F", viz., Schedule of quantities and in accordance in all respects with the specifications, designs, drawings and instruction in writing referred to in Rule 1 of General Rules & Directions and in Clause – 11 of the General Clauses of Contract and with such materials as are provided for, by and in respects in accordance with such conditions so far as applicable.

I / We have read and examined the Pre-Qualification cum notice for inviting etender, entire terms and condition of the tender documents (including all documents like annexure (s), Schedule (s), etc), which form part of the contract agreement and I/we shall abide hereby the terms/conditions/clauses contained therein.

I / We have read and examined the Notice Inviting Tender, General Rules & Regulations, Directions, form of tender, special conditions, Safety & Security codes for work contract, general condition of contract and all other contents in the tender documents for the subject work.

I / We also declare that we have not executed similar works(s) through another contractor on back to back basis. Further that, if such violation comes to the notice of Department, then we shall be debarred for bidding in BRIT/ DAE in future forever. Also if, such violation comes to the notice of the Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit / Performance Guarantee etc.

- I / We declare that all the materials / equipments shall be supplied from the list of suggest makes and execute as per tender. Our offer is un-conditional.
- I / We have downloaded and gone through the pre-bid clarifications and corrigendum(s) issued by the Department. I/we hereby unconditionally accepted the pre-bid clarification and corrigendum (s) in its totally/entirely and submitting tender accordingly.
- I / We have gone through the "Additional Notes" sheet of Financial bid/BOQ and submitting tender accordingly.
- I / We have understood the entire scope of work and rates (inclusive of GST) quoted accordingly. We shall carry out the work as per Schedule of Quantities, technical specifications, drawing and complete the work within stipulated time to the entire satisfaction of the Department.
- I / We do hereby declare that our firm has not been blacklisted/debarred by any Govt. Department/Public sector undertaking.
- I / We have read the clause regarding restrictions on Procurement from a bidder of a country which shares a land border with India, and I / we am/are not from such a country " or, from such a country which share (indicate country.....), have been registered with Competent Authority" and submit a certificate herewith as an evidence of valid registration by the Competent Authority". I/We hereby certify that I/We am/are fulfilling all requirements in this regard and eligible to be considered. I/we acknowledge the right of the Employer that absence of such a certificate in the bid, if the Bidder belongs to such country stated above, shall disqualify the Bidder. If such declaration is found to be false or to be incorrect at any time of submission of bid or after awarding the Contract, then the said Contract will be terminated, along with such other actions as may be permissible under the relevant law of India. "Any Bidder, from a country which shares a land border with India must comply to the Order (Public Procurement No-1) & Order (Public Procurement No-2) issued by Public Procurement Division, Department of Expenditure, Ministry of Finance, Government of India vide F. No. 6/18/2019-PPD dated 23/07/2020 and its addendum from time to time."
- I / We undertake that we meet the mandatory Local Content (LC) requirement for qualifying as 'Class-I Local Supplier' as per the Public Procurement (Preference to Make in India) Policy. The Percentage of local Content in the bid is Minimum 50 %. Only Class-I Local supplier are eligible. The bidder shall be compliant to the Public Procurement (Preference to make in India), Order 2017 (Date 15/06/2017) and revised order dated 16/09/2020 (as amended from time to time) issued by Department for Promotion of industry and Internal Trade, Ministry of Commerce and Industry, Government of India.

The intending bidder must read the terms and conditions as per "SECTION – 1: NOTICE INVITING TENDERS" OF "CONDITIONS AND CLAUSES OF CONTRACT – 2008" carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

Department reserves the right of Non-consideration of Tender documents of the agencies who are not fulfilling the NIT stipulations and / or having adverse report on the works carried out by them in the past.

- Information and Instructions for tenderers posted on website shall form of tender document.
- The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website CPPP site <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a> free of cost.

**OBTAINING OF STANDARD DOCUMENTS:** In addition to the above, the prospective agencies shall be required to possess following documents with them separately, which shall form part of Tender Documents for this work. These documents can be downloaded from the BRIT website (www.britatom.gov.in). In case the agencies already possess these standard documents with them, the same need not be downloaded.

- i) Conditions and Clauses of Contract (CCC 2008)

- 6 On opening date, the contractor can login and see the bid opening process.
- 7 **Certificate of Financial Turn Over:** At the time of submission of bid, contractor may upload **Undertaking** / Certificate from CA mentioning Financial Turnover of last 3 years or for the period as specified in the bid document
- 8 PRICE BID : Schedule of price bid would appear in the form of BOQ\_XXXX .xls

The Financial Proposal/Commercial bid / BoQ format is provided as BoQ\_XXXX.xls along with this tender document at <a href="https://eprocure.gov.in/">https://eprocure.gov.in/</a>/eprocure/app. Bidders are advised to download this BoQ\_XXXX.xls as it is and quote their offer/rates in the permitted column and upload the same in the commercial bid. Bidder shall not tamper/modify downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business.

Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in **SKY BLUE** colour. While selecting any of the cells a warning appears to mandatorily fill all such cells with any value, including "0" (ZERO).

In the case of bids in two / three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.

- The Department reserves the right to accept / reject any prospective application without assigning any reason thereof.
- Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by BRIT/DAE. The performance report from the executing authority shall also be considered for shortlisting.
- 12 **IF ANY INFORMATION FURNISHED** by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in BRIT/DAE.
- The applicant may furnish any additional information which they think necessary to establish their capabilities to successfully complete the envisaged work. No information shall be entertained after last date of online submission of tenders unless it is called by the competent authority.

Note: Prospective agencies shall satisfy themselves of fulfilling all the NIT criteria before submission of the tender. Department reserves the right of non-consideration of tender of the agencies not fulfilling the stipulated criteria.
