А.	Proof of registration with Government / Semi Government organizations like CPWD, MES, BSNL, Railways, State PWDs etc. in appropriate class OR having experience in execution of similar nature of works.
B.	Should have satisfactorily completed works during the last Seven(07) years ending previous day of last date of submission of tenders. For this purpose cost of work shall mean gross value the completed work including cost of material supplied by the Government/ Client but excluding those supplied free of cost. This should be certified by an officer of below the rank of <i>Executive Engineer/Project Manager</i> or equivalent.
i)	Three similar works each costing not less than Rs.3,42,800/- (40% of estimated cost) each, or Two similar works each costing not less than Rs.5,14,200/-(60% of estimated cost) each, or One similar work costing not less than Rs.6,85,600/-(80% of estimated cost).
ii)	Similar work shall mean: Supply, Testing, Installation and commissioning of Data Cabling and Local Area Networking (LAN) components and accessories and fibre optics cabling work
Note:	The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum ; calculated from the date of completion to last date of submission of tender.

6.	On opening date, the contractor can log in and see the bid opening process.

Certificate of Financial Turn Over: At the time of submission of bid, contractor may upload Undertaking / Certificate from CA mentioning Financial Turnover of last <i>Three (03) years</i> or for the period as specified in the bid document and further details if requiredmay be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
8.	PRICE BID: Schedule of price bid would appear in the form of BOQ_XXXX .xls The Financial Proposal/Commercial bid / BOQ format is provided as BOQ_XXXX.xls along with this tender document at https://eprocure.gov.in/eprocure/app. Bidders are advised to download this BOQ_XXXX.xls as it is and quote their offer/rates in the permitted column and upload the same in the commercial bid. Bidder shall not tamper/modify downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable

9.	In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
10.	The Department reserves the right to accept / reject any prospective application without assigning any reason thereof.
11.	Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by <i>BRIT</i> , <i>DAE</i> , <i>Govt Of India</i> .
12.	IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in BRIT , DAE , Govt. Of India .
