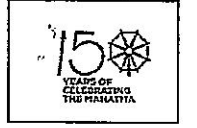



AMIE, M.Sc., B.E., B.Tech, etc. vis-a-vis with those who have been promoted directly w/o appearing in DQE/STPT on the recommendation of unit Head/Section head after meeting the Minimum Eligibility Period (MEP). Also provide copy of a report of action by the Department to resolve this issue.	
4.	Please provide the copy of decision taken by the liaison officer to extend justice to SC/ST employees in promotion seniority with regards to DoPT OM No. – 43011/153/2010Estt. (Res)dated 04/01/2013.
