परमाणु ऊर्जा विभाग के विकिरण एवं आइसोटोप प्रौद्योगिकी बोर्ड (विआप्रौबो) से संबंधित जानकारी निम्नानुसार है। As far as the Board of Radiation and Isotope Technology (BRIT), Department of Atomic Energy is concerned, the reply is as follows:-



1	<p>Board of Radiation and Isotope Technology Mumbai was supplying Ir-192 and Cobalt -60 sources to all radiography devices i.e. make in India and Imported once. But from last few years BRIT had stopped to supply Ir-192 and Co-60 sources to Imported devices. Now we have to import sources which is not economical.</p> <p>We request you to give the reason for non supply of sources Ir-192 and Cobalt-60 to imported devices.</p>	<p>BRIT is already supplying Ir-192 & Co-60 source replacement to imported devices (Foreign origin) such as IR100, Sentinel 880, Sentry 300 etc. which are having decayed/ disused source of BRIT. Since it is imported device, source is supplied in source holder/ pigtail supplied by the OEM or authorized agent of OEM. Supplier of the source holder/ pigtail has to provide an undertaking / certificate about the quality of the pigtail suitable to the device/ equipment. as required by the regulators. Servicing of device is not in the scope of BRIT.</p> <p>BRIT is also supplying Ir-192 & Co-60 replacement source to foreign origin/ imported devices which are having imported source after compliance of above-mentioned requirement and are ready to pay disposal & additional disposal charge applicable for foreign origin source. (Additional disposal charge is levied to discourage users to import instead they can go for BRIT source. As per AERB regulations & DAE policy decayed/ disused radioactive source has to go to the original source supplier. Users are importing source but they do not want to send decayed source to original supplier as it is very costly)</p> <p>BRIT is not supplying replacement source only to non-compatible imported devices such as SPEC-150/ SPEC 300/ Gammamat, due to regulatory issues.</p>
