3	Information is sought for fixing the prescribed time limit for processing several administration/ accounts process such as LTC Advance or claim, payment of arrears, House Building Advance, issuing NOC to passport, acquisition/ disposal of property etc. similar to Secretariat co-ordination Section, so that all the units of DAE such as IGCAR, NPCIL, BARC, NFC etc. can do similar work in the same time.	BRIT follow time limits set by the Government from time to time.
4	Information is sought for taking necessary action/ providing proper time limit and guidance for all Administration and accounts staff towards completion of their respective queries and routine work within the prescribed time.	As far as BRIT is concerned, guidelines as prescribed in Manual of Office Procedure is followed.
5	Information is sought for maintain equality towards all working employees of DAE so that the time limit for completion of routine work done by administration and accounts staff similar to the time limit fixed for technical auxiliary and scientific employees of DAE.	As far as BRIT is concerned, equality among all employees towards time limit for completion of routine work being followed.
