GeM has no restriction for the bidders to quote beyond $\pm 10\%$ of the estimated cost of buyer and hence the bidder has quoted lesser than 10% of the estimated cost. L1 bidder was awarded this service contract based on their undertaking for the complete understanding of the scope of service to be rendered within the quoted price along with T&C mentioned in the GeM tender.
