## PART B: TENDER REQUIREMENTS FOR ELIGIBILITY

- 1 **Contractors who fulfil the following requirements shall ONLY be eligible to apply. (Joint ventures are not accepted).**
- 1.1, **Proof of registration** with Government / Semi Government organizations like CPWD, MES, BSNL, Railways, State PWDs etc. in appropriate class OR having experience in execution of similar nature of works.
- 1.2 Should have satisfactorily completed works during the last seven years ending previous day of last date of submission of tenders. For this purpose cost of work shall mean gross value the completed work including cost of material supplied by the Government/Client but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer / Project Manager or equivalent.  
  
Three similar works each costing not less than Rs. 5.44 lakh each,  
OR  
Two similar works each costing not less than Rs. 8.15 lakh each,  
OR  
One similar work costing not less than Rs. 10.87 lakh  
  
Note : i) **Similar work shall mean** ; Construction of civil works with value of RCC works should be at least 50% of total work order value.  
  
ii) The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for bids.
- 1.3 Should have had average annual financial turnover of Rs. **13.59 LAKHS** on construction works during the last three years ending **31st March, 2021**.
- 1.4 Should not have incurred any loss in more than two years during the last five years ending **31st March, 2021**.
- 1.5 Should have **Bank solvency certificate** of minimum value **Rs. 5.44 Lakhs**
- 1.6 **Latest income tax clearance certificate** (Last 3 years)
- 1.7 **List of construction plant, machinery**, equipments, accessories & infrastructure facilities possessed by the agency to complete the work in time.
- 1.8 **List of Technical staff** they possess.
- 1.9 **Performance** Certificates.
- 1.10 **GST** registration certificate.
- 1.11 **PAN** (Permanent Account Number) Registration.
